




#### **Natural Gas Market**


#### **Total Natural Gas Consumption**









#### **Breakdown of Natural Gas Consumption**





### **Other Important Measures in Türkiye**


- Since 1 January 2022, the gradual tariff has been started to be implemented for household low voltage (LV) single-time subscriber group. Daily average 8 kWh and below are low levels.
- Since 1 March 2022 the gradual tariff has been started to be implemented for commercial low voltage (LV) single-time subscriber group electricity users. Daily average 30 kWh and below are low levels.
  - The VAT rate implemented with electricity consumption has been reduced from 18% to 8% for irrigation and household consumers since 1 March 2022

Household Low Level (monthly 240 kWH and below)	1.73 TL/ kWh
Household High Level (monthly 240 kWH above)	2.60 TL/ kWh
Commercial Low Level (monthly 900 kWH and below)	2.71 TL/kWh
Commercial High Level (monthly 900 kWH above)	3.61 TL/kWh
Yearly Average MCP (1 January-23 November)	2.37 TL/ kWh
