Prof. Pandelis Biskas, Associate Professor in the Department of Electrical and Computer Engineering of Aristotle University of Thessaloniki (AUTH), Greece

Pandelis Biskas was born in Serres, Greece, in 1977. He received his Diploma in Electrical Engineering from the



Aristotle University of Thessaloniki, Thessaloniki, Greece, in 1999 and his Ph.D., degree from the same university in 2003. He also performed his Post Doc research from March 2004 till August 2005 in the same university.

From March 2005 till July 2009 he was a power system specialist at the Hellenic Transmission System Operator (HTSO), Market Operation Department, where he worked on the development of the Greek wholesale electricity market and on the procedures for the auctioning of the Physical Transmission Rights (PTRs) in the interconnections with neighboring countries.

Currently, he is an Associate Professor at the Aristotle University of Thessaloniki, in the School of Electrical and Computer Engineering. His research interests are in power system operation & control, in electricity market operational and regulatory issues, and in transmission pricing. He was a Principal Investigator in more than 55 research projects and participated as a senior researcher in another 30 projects. He has 47 papers in international peer-reviewed journals and above 55 papers in international conference proceedings. He is a member of the Technical Chamber of Greece, IEEE and CIGRE.

#### Dr. Teodor Chirica, Chairman of the Board of Directors Nuclearelectrica

Teodor Chirica (PhD) is currently the Chairman of the Board of Directors of Nuclearelectrica. An engineer with



extensive experience in nuclear energy, actively involved in the development of CANDU projects in Romania since the early '80s, Teodor worked for ISPE, CITON and RENEL, as well as for CANDU Owner Groups. From 1998 Dr. Chirica served in different managerial positions at Nuclearelectrica, a company that he also led as CEO (2005-2009). He also acted as Managing Director of AMEC Nucleare Romania (2009-2013), as CEO of EnergoNuclear – the SPV for Cernavoda Units 3&4 (2013-2017) and as advisor to the CEO of Nuclearelectrica (2017-2019). Mr. Chirica was President of the European Atomic Forum (FORATOM, now called Nuclear Europe) between 2018-2019 and a member of the

FORATOM board between 2006-2023. His international experience includes also a year spent with CANDU Owners Group (COG) in Canada (1992-1993), negotiation (for the first time in Romania), on the international nuclear insurance market, of the insurance policies related to Units 1 and 2 of Cernavoda NPP, negotiation with international banks for financing Cernavoda Unit 2, but also with EURATOM, as well as the negotiation of the first Investor Agreement for Units 3 and 4, involving international partnerships, in 2008. He holds a PhD in nuclear sciences from the "Politehnica" University of Bucharest, on the management of radioactive waste, focusing on the decommissioning of nuclear installations. He is also one of the founders of the Romanian Atomic Forum - ROMATOM (2000) and was instrumental in affiliating ROMATOM to FORATOM. Since 2019, Teodor Chirica is the honorary president of ROMATOM.

Ambassador Michael B. CHRISTIDES is the Secretary General of the Permanent International Secretariat (PERMIS) of the Organization of the Black Sea Economic Cooperation (BSEC), headquartered in Istanbul, Turkey. Born in Thessaloniki, Greece in 1949, Ambassador Christides joined the Hellenic MFA in 1976 as first in his Class and served with distinction until his retirement in August 2014. Among other assignments he served as Ambassador of Greece to Bulgaria, to Turkey and to Argentina and held senior posts in the Hellenic MFA as

Political Director for South East Europe, as Director General for International Organizations, International Security & Cooperation and as Director General for International Economic Relations.

Ambassador Christides participated in many international meetings and conferences and has spent more than 20 years dealing with S.E. European / Balkan issues, while travelling extensively in the region. He acquired a broad knowledge of the political and economic realities there and established a wide personal network of high-level political, business, academic and media contacts. He speaks fluent English, German, French, Italian and moderately good Spanish.

After his retirement Ambassador Christides was elected by the BSEC Council of Ministers of Foreign Affairs as Secretary General of the BSEC PERMIS, assuming his duties on 1 July 2015. After the unanimous endorsement by all BSEC Member States, the same Council of Ministers of Foreign Affairs reappointed on 15 December 2017 Ambassador Christides for a second three-year term-in-office, as of 1 July 2018 until 30 June 2021.
