

The transition from fossil fuels to renewable energy




Study: existing oil & gas fields would exceed the carbon budget for 1.5 C-





Energy Import Dependence (%) in SE Europe (2016)




Higher energy import dependence → vulnerability to supply disruptions & energy security concerns

4 priorities in Greece's energy strategy


- 1. Ensuring adequacy in energy sources and security of supply through development of infrastructure,

Concession areas currently leased or in operation





2013/30/EU Offshore Safety Directive (OSD)

Law 4409/2016 (transposition of the OSD) HHRM SA appointed Competent Authority July 2016

External Emergency Response Plan




HHRM's activities in 2018

In 2018 HHRM:

- Assessed and Accepted 3 Reports on Major Hazards
- Assessed 6 Notifications of Well Operations
- An Inspection has been conducted on a Mobile Drilling Unit
- Is currently assessing a Design Notification for a new platform and 2 Notifications of Well Operations
